This Privacy Policy is our way of telling you how we collect your information, why we need it and how we use it.

We are committed to protecting your privacy. Parts of the website can be viewed without giving us any data about yourself. However, for certain areas of the Website and for certain functions, you may be required to enter or we may collect personal data.

## Your Data

We may ask you to provide us with data that personally identifies you or allows us to contact you. The data we usually collect may include your name, company name, address, contact telephone number, email address and job title.

Most of the personal data we process is provided to us directly by you for one of the following reasons:

- Marketing agencies, search engines and social media networks to advertise Veterinary Insights Limited and to gather feedback on our services.

### **Your data protection rights**

Veterinary Insights would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

**The right to access** – You have the right to request Veterinary Insights for copies of your personal data.

**The right to data portability** – You have the right to request that Veterinary Insights transfer the data that we have collected to another organisation, or directly to you, under certain conditions.
